3. Board of Supervisors Liaison Report, BOS Monthly Report:

Please see the report for updates.

- The Board is continuing to review budget requests from the various County departments and other County elected offices. The Board will adopt a tentative budget in May and final adoption in the 3rd week of June for the budget year to begin on July 1st, 2022. Then in August the Board will adopt/adjust the County tax rate to support the Fiscal Year 2023 budget.
- In addition to working on the budget, the Board of Supervisors is getting ready for the 2022 election, a Primary in August, and a General election in November. The Board shares responsibilities for the administration and running of the Election with the County Recorder.
- County Attorney Alister Adel resigned her office last week. The Board is responsible for appointing a new County Attorney to fill the
 vacancy until the November 22 election. The Board of Supervisors is currently working on the application process to find a new
 County Attorney.
- In Head Start related issues; The Board of Supervisors at last Wednesday's Formal meeting; approved the Head Start application process to the Federal Government for the continuation of funding to begin in July of this year.
- The Board of Supervisors received The Head Start Program Report for January, which includes information on the number of children and families being served.
- In an effort to address the issue of the lack of affordable housing in Maricopa County, The Board of Supervisors has awarded 3
 contracts to non-profits and companies to increase affordable housing stock/inventory in the next 2 years. This is round one which
 totals 14 million dollars. In mid-summer, the Board will consider the second round of funding.

4. Head Start Director Report

- The funding application to continue providing services is under review and will be submitted on Wed, March 30th. Thank you for the approval during last month's meeting- the application strongly represents our efforts to continue high quality early learning
- The program completed the filming of its social media, TV, and radio ads. Last week Maricopa County Head Start's Director, Eve Del Real completed filming several segments for Univision. The social media ads are increasing local awareness of our services.
- A solicitation in search of additional childcare partnerships will be released within the next week. We encourage families to share this opportunity to offer head start services with local childcare providers.

5. Program Services Report

Family Services, Community, and Partnerships

Family Support Specialists were trained to complete vision and hearing screens. Our program will begin applications for our new program year beginning April 4th. If the applications were complete between January and April 4th, the application will rollover. Our program is interested in recruiting employees and children into our program.
